13. Families First Coronavirus Leave

Action

On December 31st, 2020, the Families First Coronavirus Leave Act (FFCRA) expired. This is the law that allowed employers to provide up to 80 hours of paid leave for employees with COVID 19. However, the law does allow employers to continue the leave voluntarily until March 31st, 2021 if they choose to do so.

After collaboration with the Teacher and Support Staff Associations and District Leadership, and pending School Board approval, Charles City Community Schools will extend the leave provisions until March 31st 2021. All of the leadership felt this was what was best for our family and meets our mission of being a "regardless school".

The recommendation of the superintendent is:

The Iowa Department of Transportation (DOT) is requesting approval of an agreement for work on District property around Lincoln Elementary for sidewalk construction. 15. Modified Supplemental Amount - At-Risk/Dropout

The purpose of the requested Modified Supplemental Amount is to provide additional resources for the 2021-2022 school year that are necessary to implement the at-risk, dropout prevention, and returning dropout services for identified students that are included in our School District adopted plan. The drop out services provided in the past include Juvenile Court liaison officer, intensive guidance services, school based youth services, school within a school, Carrie Lane alternative program, math, reading and science workshops, Intervention room, behavior interventional, summer school, and before and after school programs.

The recommendation of the superintendent is:

"to approve the 2021-22 At-Risk/Dropout request for modified supplemental amount totaling \$476,408 as recommended."
