Action

The Charles City Community School and Pike County Schools in Georgia have been in a 2 year partnership of mentoring and sharing of resources. We have worked with them through their execution of their Portrait of a Graduate and essential competencies that led a reframing of teaching and learning. Mike Fisher visited two years ago and since then, we have maintained regular zoom meetings for mentoring and sharing of resources. In

addition, they have begun learning from us about our leadership focus and how that is being utilized to help kids also reach their maximum potential.

We have had several requests by staff to visit Pike County Schools in person to better see problem based learning in action. We have a budget of ESSER money that could be used to fund this project.
